The Board meeting will be held at 9001 NW Hwy 287 Ft. Worth, TX 76131 in the Great Hearts Prairie View school building. It is the intent of the Board to have a quorum physically present at the above address. Board members not physically present may participate by live two-way video and audio feed in accordance with the Texas Open Meetings Act. If a quorum of the Board cannot be physically present at the above address, it is the intent to have the presiding officer physically present at the above address. Items will not necessarily be discussed or considered in the order they are printed on the agenda below. If, during the course of the meeting, discussion of any item on the agenda should be held in an executive or closed session, the Board will convene in such executive or closed session as permitted by and in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551.

Pursuant to Sec. 551.007(b), the Board will allow members of the public who desire to address the Board regarding a specific item on the agenda, before or during the Board's consideration of the item at the meeting.

Persons desiring to address the Board verbal in-person, verbally via Zoom, or in writing may register for public commit or submit their written public commit by completing the Public Comment Sign-Up Form (https://forms.gle/SKhC2wtADPWncG4m7).

The deadline to register to address the Board is 5:00 p.m CST on Thursday, November 7, 2024. The Great Hearts Texas Public Comment agenda item will be limited to 45 minutes in total. Members of the public may have up to two (2) minutes to speak; however, depending on the number of speakers, the board meeting chair may limit the time allotted to fewer than two minutes in order to allow as many registered members of the public to be heard during the agenda item.

The speaking order will be determined on a first-come, first-served basis and according to the timestamp of when the individual registers. No individual presentation shall exceed two (2) minutes. In the event an individual uses a non-simultaneous translator when addressing the Board, the individual shall be permitted twice the allotted time to make his or her presentation.
