## **V. Superintendent Report**

### **A. Academic Update**

- Mrs. Lessner reported strong End of Course results, with U.S. History meeting the 90/60/30 goal (90% passing, 60% Meets, 30% Masters).
- Reading STAAR nearly reached these goals across most grades.
- 8th grade Science showed solid passing rates but still has growth opportunities.
- Math remains the main area for improvement.
- Mr. Linville presented preliminary STAAR data and explained the accountability formula, which includes CCMR. By offering the TSIA2 assessment, Great Hearts TX increased the number of seniors meeting CCMR requirements this year.
- Dual Enrollment has been piloted at Great Hearts Irving Upper School by 43% of the Junior and Senior class. 100% of scholars that signed up for dual credit courses passed the course.
- AP scores will be released July 9.
- Courses offered Spring '26 will include ENGL 1301, Latin 1301, Hist 1301, Phil 2306, Speech 1315, and Economics 1301 (Tentative). AP Exams that will be offered in Spring 2026 will include Latin, Calculus AB, and Physics I.

### **B. Operations Update**

Updates:

- TEA conducts safety audits every 4 years, and GHTX was selected by lottery to be audited this year. The agency gave positive feedback on campus SOPs, with all employees passing safety interviews. The audit reviewed policies, procedures, visits, and staff readiness.
- GHTX also piloted the state's new Sentinel Program, positioning them ahead of statewide rollout in 2025–26. Additionally, GHTX is preparing its Emergency Operations Plan, due to the state in September 2025.
- GHTX has achieved 95% of its 11th-day fall enrollment goal with a record-high 96% re-enrollment rate for 2025–26, resulting in a 10% overall enrollment increase. A waiting list of 4,700 students reflects successful outreach efforts. Using

a predictive attrition model, GHTX has been within 0.5% of its enrollment targets over the past two years.

- GHTX's Average Daily Attendance rose to 95.4%—0.3% higher than last year and above the 93% state average—earning \$380,000 in state funding. Chronic absenteeism is 9%, well below the Texas average of 15%, due to focused efforts on attendance and reducing absences.
- The real estate team is on track with multiple projects: Arlington Phase II (with a second MPR and full chemistry lab) will finish in June; Irving Lower School (with new amenities) will complete in July; Koehler House is set for Spring 2026; and Phase II designs for Invictus and Prairie View are ready for Board approval.

### **VIII. Finance Update**

#### **A. Review YTD Financial Report**

- Enrollment by month - Actuals for FY 2025 with state funding based on 12,221 students
- The FY26 Budget is based on 13,941 enrollments. GHTX enroll at 102% enrollment on the 11th day of enrollment.
- FY26 Estimated HB2 State Funding- Basic allotment increased \$55 per student, plus fixed cost component and teacher pay raise tied to experience.
- Budget Outlook – Conservative estimate of \$5.8M for HB2 includes 3% staff raises and teacher allotment eligibility.
- Grant Opportunity – Potential \$6M CSP federal grant over 5 years.
- Statement of Activities - Expected to land at \$1.7 - \$2 million loss. Debt service coverage ratio has to land at 1.1 which we should meet.
- Statement of Financial Position- Optimistic that TEA will resolve SY 23–24 data corrections this summer to release pending online funding.

#### **B. ESSA Funds Application Announcement**

Great Hearts Texas supports educational services through the Every Student Succeeds Act (ESSA). This is an annual application that is submitted to the Texas Education Agency for approval of funds. As part of the process for applying for funds, GHTX is required to gather feedback through public comment. Public comment will be welcomed through a survey link that will be shared out on Sunday, June 15, 2025, and will remain open until Saturday, June 28, 2025.
