

**BOARD RESOLUTION OF GREAT HEARTS AMERICA – TEXAS  
CHARTER HOLDER OF GREAT HEARTS TEXAS**

**ANNUAL WRITTEN CERTIFICATION FOR REAL ESTATE TRANSACTIONS  
2025-2026 SCHOOL YEAR**

**WHEREAS**, Section 12.1058 of the Education Code requires an open-enrollment charter school to certify in writing that no administrator, officer, or employee of the charter school and no member of the governing body of the charter school or its charter holder derives any personal financial benefit from a real estate transaction with the charter school; and

**WHEREAS**, Section 12.106(e-2) of the Education Code requires the Board of Directors to annually certify, in writing to the TEA, that no officer, administrator, employee, board member or any person related within a prohibited degree by blood or marriage, “derives any financial benefit from a real estate transaction with the school”; and

**WHEREAS**, the Board of Directors of Great Hearts Texas, a Texas non-profit corporation and open enrollment charter school, desires to make such certification in compliance with law and further direct the Superintendent/CEO to provide such certification in writing to the TEA as directed and to any municipality or other political subdivisions within whose jurisdiction the School operates or intends to operate an open-enrollment charter school, and to take all other actions deemed necessary to avail the School of similar protections under the law;

**NOW, THEREFORE**, the Board of Directors of Great Hearts Texas, at a lawfully called meeting held in compliance with the Texas Open Meetings Act, hereby adopts the following Resolutions:

**BE IT HERBY RESOLVED:**

- That the Board of Directors certifies that no administrator, officer, or employee of Great Hearts Texas and no member of the Board of Directors, and no person related within the third-degree by consanguinity or second degree by affinity, derives any financial benefit from a real estate transaction with Great Hearts Texas.
  
- That the Superintendent/CEO of Great Hearts Texas, is directed to provide notice of this certification in writing to the TEA and to any municipality or other political subdivision within whose jurisdiction Great Hearts Texas operates or intends to operate an open-enrollment charter school, and to take all other actions deemed necessary to avail the school of similar protections under the law.
